MBA in International Business Practice combined with work placements in London or New York, and followed by Asia Pacific field study based in Bangkok, Thailand.

PGC - 1 year, MBA - 16 months

March and August

### Postgraduate Certificate:

The PGC coincides with a year's paid training internship in either London or New York.

### MBA:

The MBA similarly proceeds through the placement year and is followed by four months of full-time field study and research in the Asia Pacific Region, based in Bangkok, Thailand.

### Academic Schedule:
